

**PUBLIC NOTICE**  
**Air Quality Construction Permit For**  
**The United States Department of Energy**

The United States Department of Energy (US DOE) has submitted an application for a modified air quality construction permit to the Air Quality Program (Program) of the City of Albuquerque Environmental Health Department. The application was received by the Program on August 20, 2019. The owner of the facility is US DOE, 1515 Wyoming Boulevard SE, Albuquerque, New Mexico 87059. The facility, Sandia National Laboratories – New Mexico, is located at Building 833, G Street/Frost Avenue SE and Golden Smoke Drive SE, Albuquerque, New Mexico 87185. This application file has been assigned **Permit Application No. 2097-M3**. The Program has made an affirmative administrative completeness determination and is providing this notice pursuant to 20.11.41.14 NMAC.

The applicant is requesting a modification to Permit #2097-M2. The applicant proposes to install three (3) small natural gas generators (two with a power of 15-kilowatts (kW) and one of 6kW). The combined hours of operation for these three generators will be less than 400 hours per year. The modification request also reflects a reduction in the hours of operation for the existing Emission Unit No. 1 (250kW diesel-fired generator) from 1,000 hours per year to 500 hours per year.

The proposed air pollution maximum allowable emissions from this facility have been estimated to be:

<sup>1</sup>The proposed total emission in this notice could change slightly during the course of the Program's review of the application.

The Program has conducted a preliminary review of the information submitted with the permit application. The Program's preliminary review of the information submitted with the permit application included an evaluation of the emission rates and applicable requirements to determine compliance with the Title 20, New Mexico Administrative Code (NMAC), Chapter 11, Part 41 and the New Mexico Air Quality Control Act.

A copy of the permit application, all supporting documentation, and the Program's technical analysis, if and when it is completed, may be inspected by the public at the Program offices at Room 3047, One Civic Plaza NW, Albuquerque, NM. Any person who wishes to receive notice of the availability of the Program's technical analysis for review and comment, must express request notice in writing to the Program at: Albuquerque Environmental Health Department, Air Quality Program – Permitting Section P.O. Box 1293, Albuquerque, New Mexico 87103 **before the end of the public comment period on October 28, 2019**. The public will have no fewer than 30 days to submit written comments and evidence, request a public information hearing, or both on the permit application to the Program. Comments will be accepted and considered if postmarked by the end of the public comment period. Formal action on the application will be reserved pending receipt and analysis of any additional details or information developed during the public

comment period. Any person who does not participate in the permitting action will not receive notification of the Program's decision regarding the proposed permit, unless the person has delivered a written request for notice to the department. The application, all supporting documentation, and the public notice are available online at <http://www.cabq.gov/airquality/air-quality-permits>.

The Program shall hold a Public Information Hearing pursuant to 20.11.41.15 NMAC if the Director determines there is significant public interest and a significant air quality issue is involved.

The Program expects to issue, issue subject to conditions, or deny this application before December 18, 2019. The Program will not issue any air quality permit with or without conditions unless an air quality ambient impact dispersion modeling study, if deemed necessary by the Program, shows that the facility would not cause or contribute to a potential violation of air quality standards. If the Program issues the permit with conditions, the conditions will include those that limit the emissions, and conditions that will require recordkeeping and reporting to the Program to ensure compliance with federal and local air regulations.
