NOTICE OF PUBLIC INFORMATION HEARING FOR PROPOSED AIR QUALITY CONSTRUCTION PERMIT APPLICATION #3291-M1 FOR ALBUQUERQUE ASPHALT, INC.

A Public Information Hearing (hearing) will be held on Thursday, April 26, 2018 from 6:00 p.m. to 8:00 p.m. at the Mountain View Community Center, 201 Prosperity Ave SE, Albuquerque, NM 87105. The purpose of the hearing is to provide information and answer questions regarding the proposed Air Quality Construction Permit Application #3291-M1 for Albuquerque Asphalt, Inc. The location was chosen to accommodate the significant public interest that has been expressed in this matter.

Albuquerque Asphalt, Inc. has submitted an air quality construction permit application to modify Construction Permit #3291-1AR to the Air Quality Program (Program) of the City of Albuquerque Environmental Health Department. The operation is a hot mix asphalt plant and recycled asphalt/concrete crushing plant located at their facility at 5028 Broadway Blvd. SE. The owner of this facility is Albuquerque Asphalt, Inc., 202 94th St. SW, Albuquerque, NM 87121.

The maximum air pollution emissions to the atmosphere from this facility have been estimated to be:

Carbon Monoxide (CO) – 55.6 pounds per hour (lbs/hr) – 65.3 tons per year (tpy), Nitrogen Oxides (NOx) – 36.1 lbs/hr – 52.7 tpy, Sulfur Oxides (SOx) – 23.4 lbs/hr – 27.1 tpy, Total Suspended Particulates (TSP) – 27.8 lb/hr – 35.6 tpy, 10 Micron Particulate Matter (PM₁₀) – 15.4 lb/hr – 18.9 tpy, 2.5 Micron Particulate Matter (PM_{2.5}) – 11.3 lb/hr – 13.3 tpy, Volatile Organic Compounds (VOC) – 20.4 lb/hr – 22.7 tpy, Hazardous Air Pollutants (HAPs) – 4.72 tpy

Representatives for Albuquerque Asphalt, Inc. will speak regarding the proposed Construction Permit Application and will be available to answer questions. Program staff will be available to answer questions regarding the review process for air quality permits and the status of Albuquerque Asphalt, Inc. Construction Permit Application #3291-M1. The public will have an opportunity to voice concerns and submit data or arguments, orally or in writing, for the public record regarding the application. Those who wish to do so at the April 26, 2018 public information hearing should sign the registry upon their arrival at the hearing. The length of comments and testimony may be limited in order to allow each individual an opportunity to provide comments and testimony.

Program staff will consider relevant testimony and documentation submitted at the public information hearing before making a decision on the Construction Permit Application.
