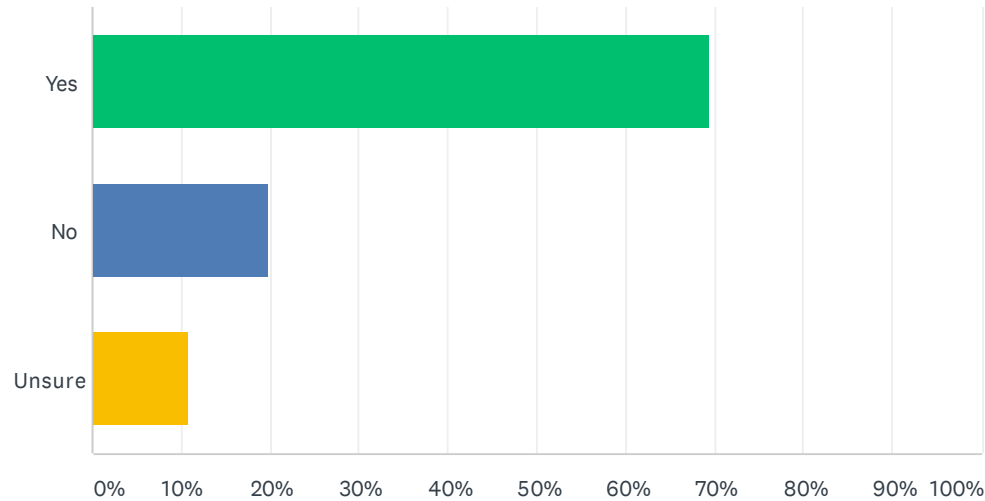


Q1 Do you support adding the Community Safety department as a third 911 emergency response option (Police, Fire/Emergency Medical Services, and Community Safety)?

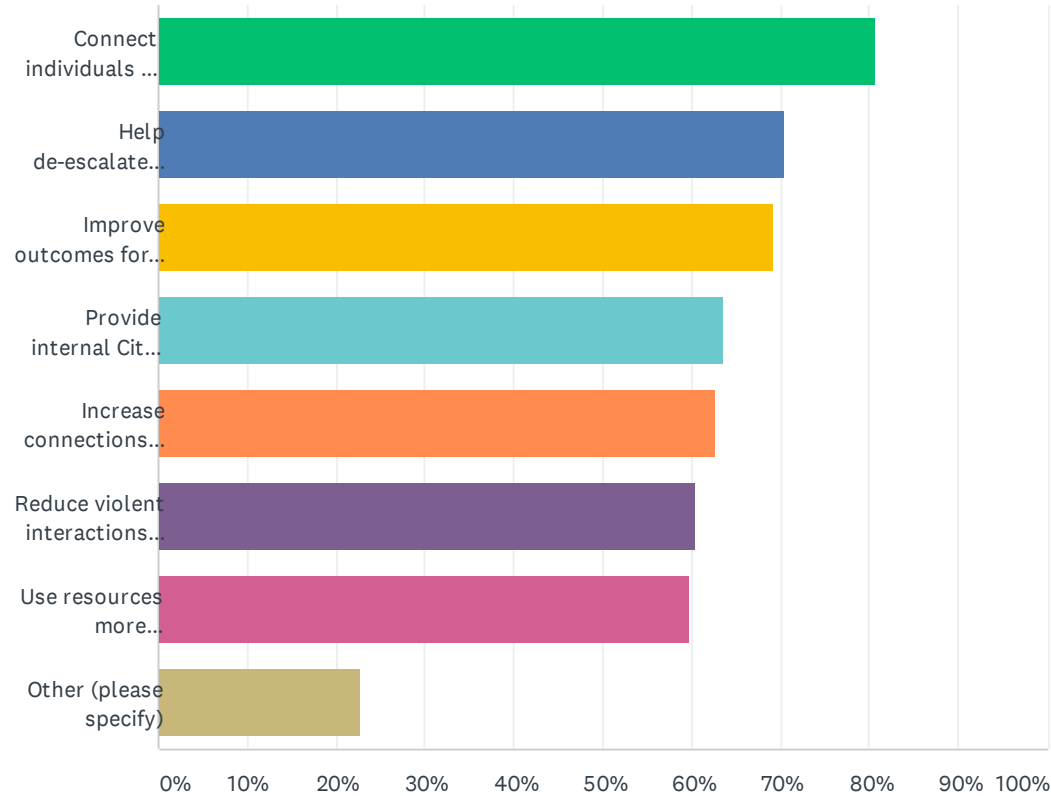

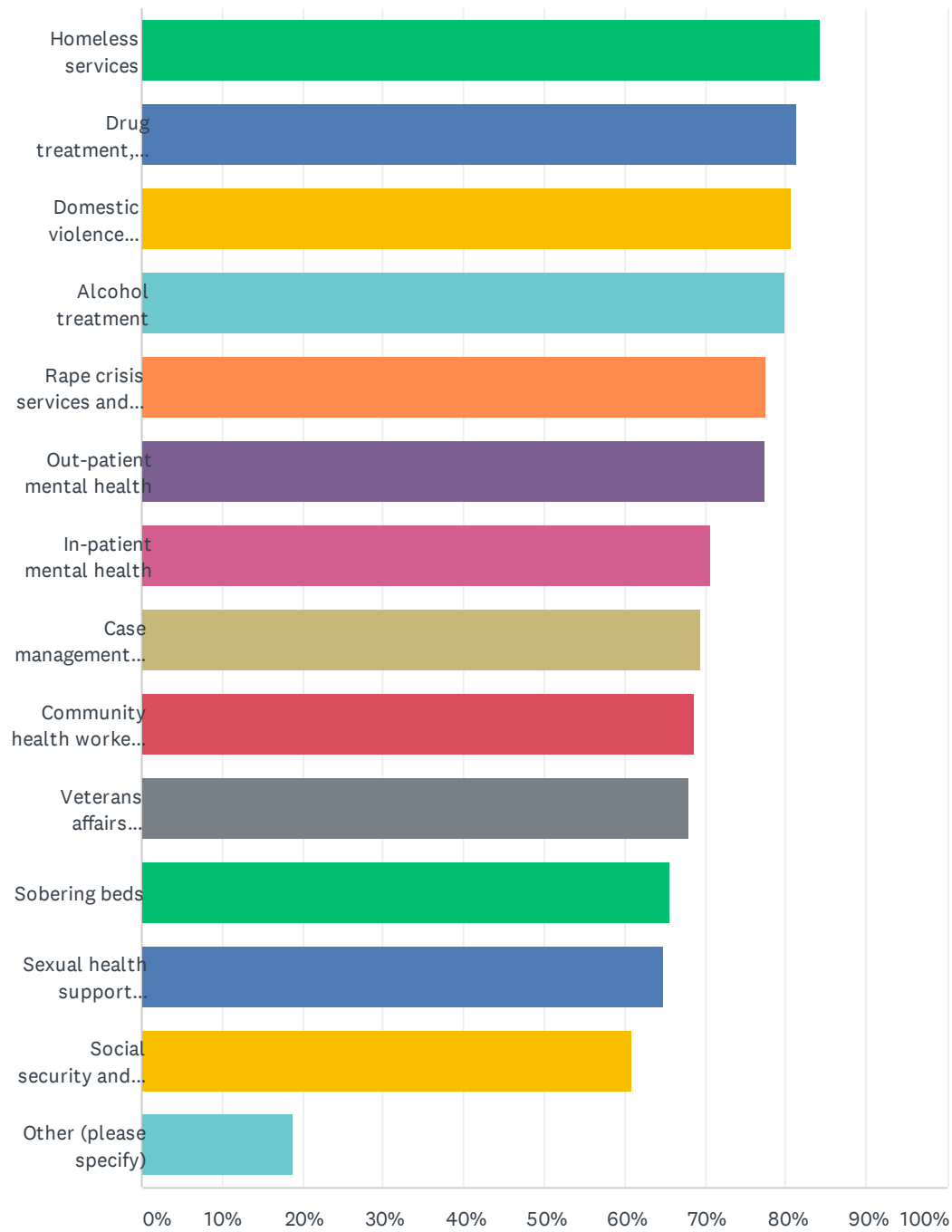

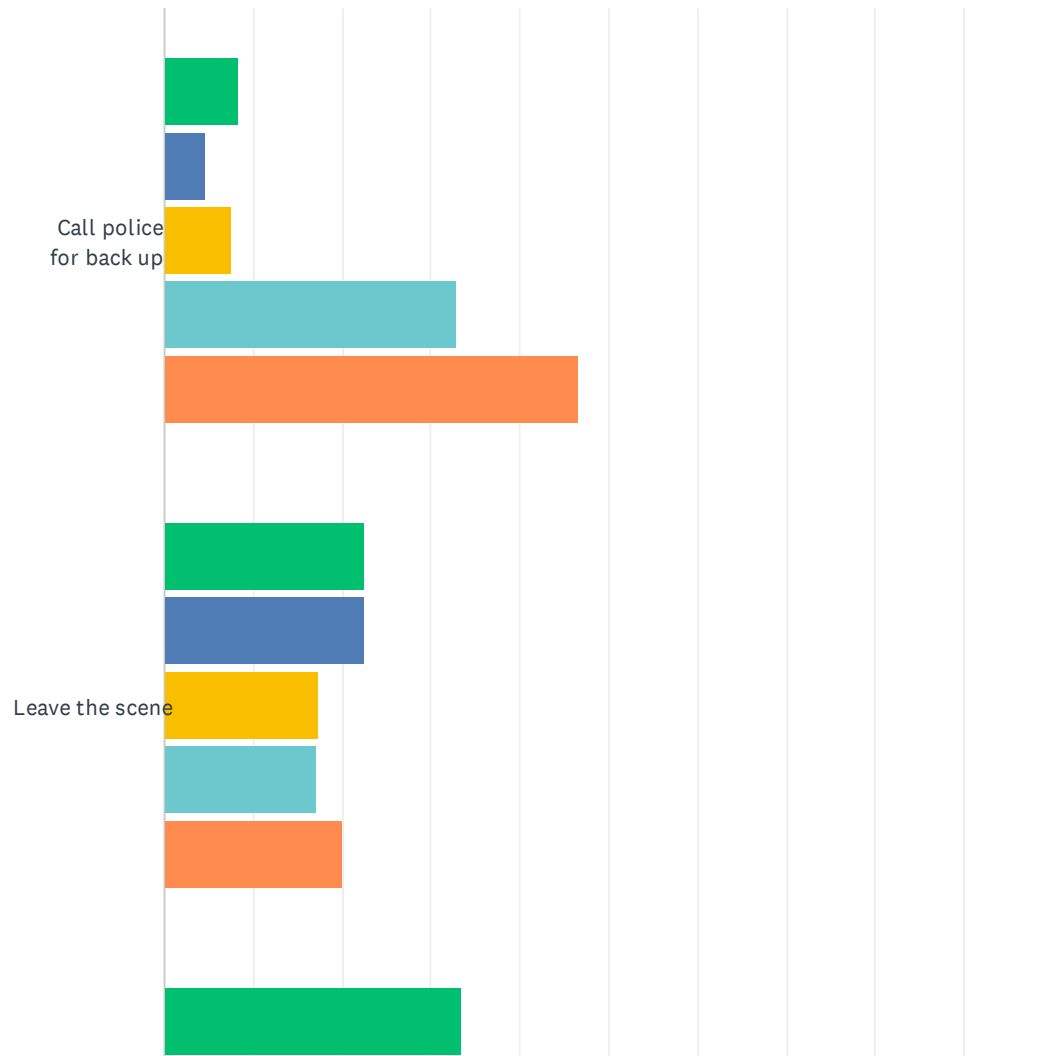

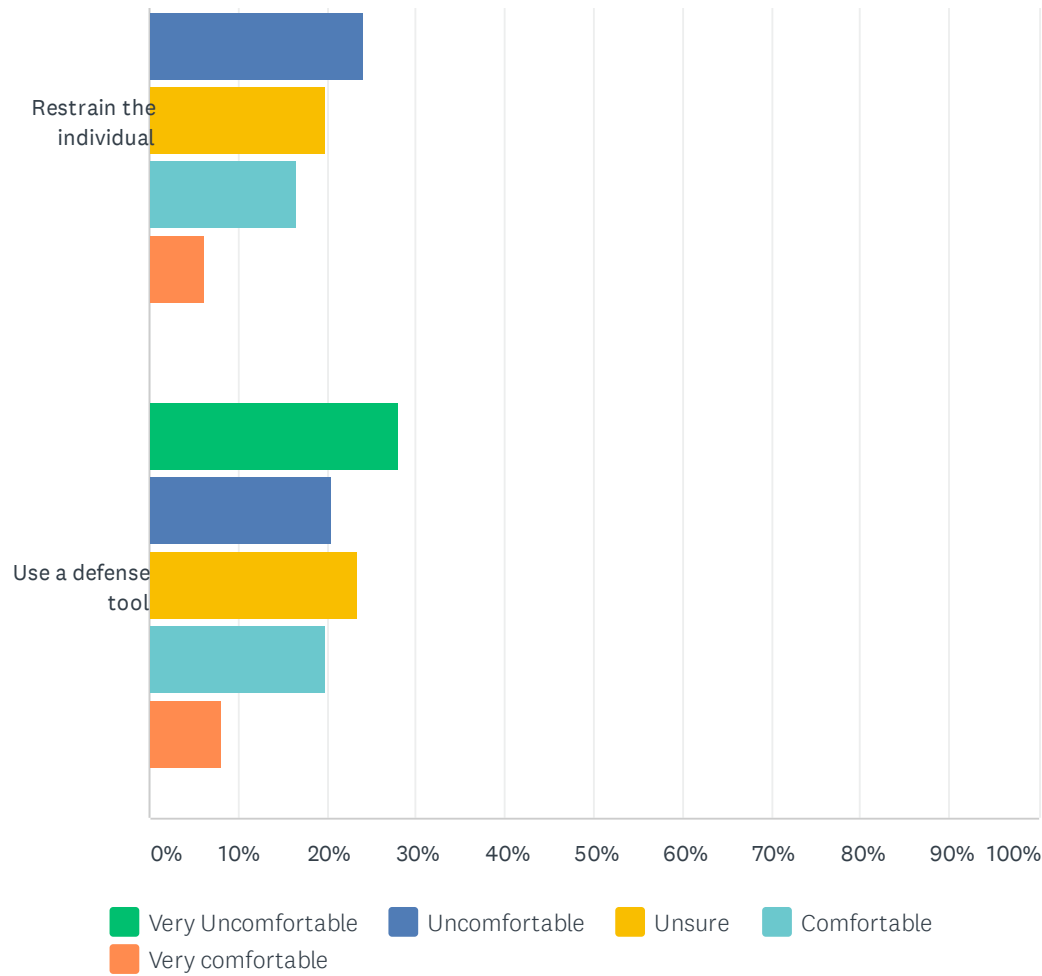

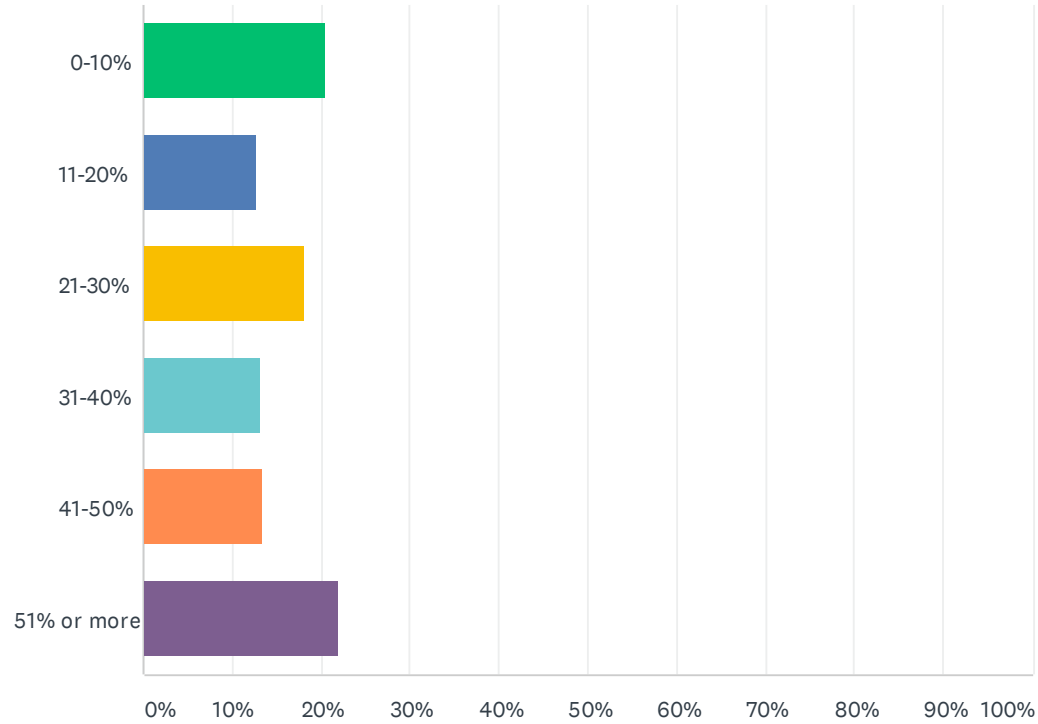

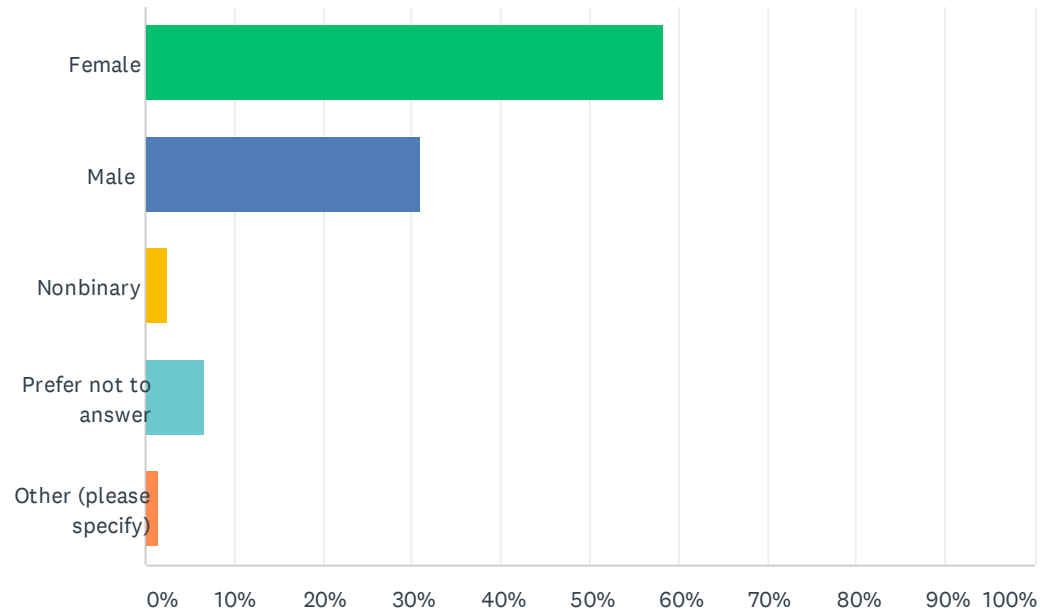

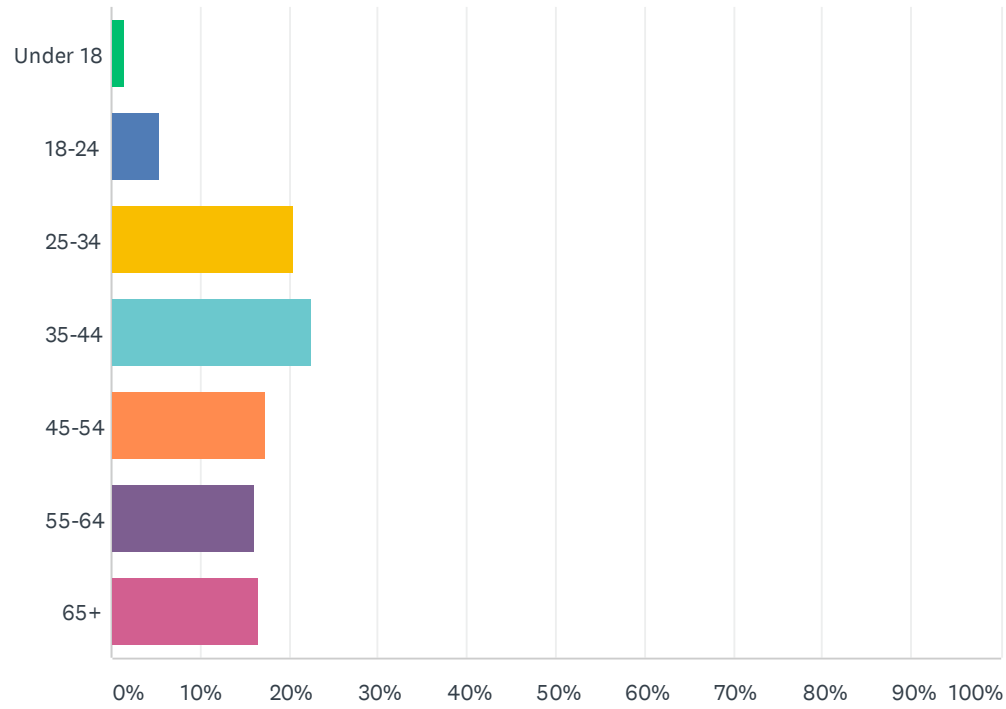

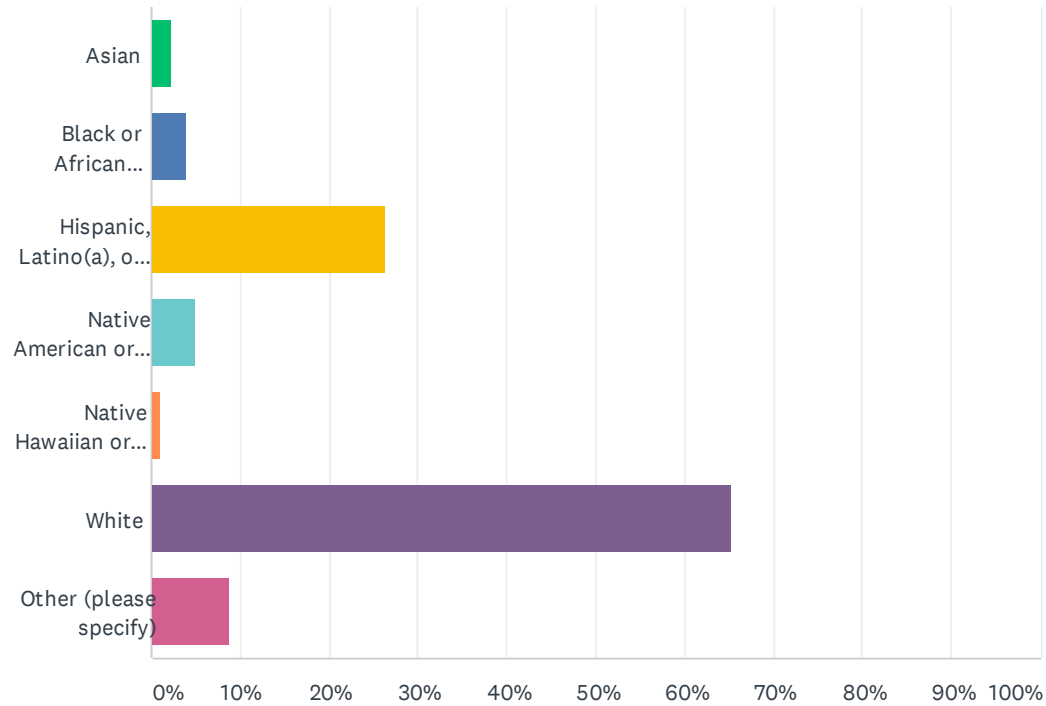
