POSITION SUMMARY:

Provide professional behavior health services working with Albuquerque Police officers, Sheriff's deputies, and first responders to provide crisis intervention to adults and children who are experiencing or are at risk for experiencing a behavioral health crisis; work on scene, conducted mental health assessments, engage in de-escalation, make appropriate referrals, and conduct follow up services; work collaboratively with law enforcement, area hospitals and partnering agencies to coordinate services.

This is a safety sensitive position subject to random drug/alcohol testing.

This is an unclassified at-will position

SUPERVISION RECEIVED AND EXERCISED:

Receive direction from higher level staff.

ESSENTIAL AND SUPPLEMENTAL FUNCTIONS:

ESSENTIAL FUNCTIONS: (Essential functions may include, but are not limited to the functions listed below)

- 1. Respond in person with assigned law enforcement officer/first responder, or by phone, to requests for assistance with citizens in crisis who may have psychological and/or associated mental health emergencies and chronic mental illness.
- 2. Prepare and maintain written reports that contain confidential clinical material; ensure compliance with state and federal privacy.
- 3. Evaluate a wide range of crisis issues and supply appropriate information and referral services to resolve issues.
- 4. Conduct concise and mobile bio-psychosocial evaluations of clients experiencing an acute psychiatric emergency.
- 5. Assess safety and determine services needed to make appropriate referrals, considering client preferences.
- 6. Provide short term, solution focused clinical intervention.
- 7. Participate in the development of safety and crisis management plans to assist individuals in maintaining personal safety and the safety of those around them when under increased stress.
- 8. Actively engage individual in crisis and their natural supports and treatment providers in this process and plan development.
- 9. After assessment, and only when appropriate, write a Certificate of Evaluation that will allow for safe transport to the hospital.
- 10. Train new Mobile Crisis Team clinicians.
- 11. As requested, help with the development and delivery of training for police officers, community groups, and other clinicians.
- 12. Maintain contact with civic groups, social services organizations, and other professionals; develop and present information to local providers and civic groups.
- 13. Assist in training department and community personnel for the implementation of crisis intervention strategies.
- 14. Be available to take on-call phone periodically.

SUPPLEMENTAL FUNCTIONS:

1. Perform related duties and other assignments as needed.

Master's Degree in Social Work, Counseling, Psychology or related field; and

Three (3) years of experience working as a qualified mental health professional licensed for independent practice within the following areas:

- Licensed Professional Clinical Counselor (LPCC)
- Licensed Marriage and Family Therapist (LMFT)
- Certified Nurse Practitioner (CNP)
- Clinical Nurse Specialist (CNS)

Experience in crisis descalation preferred.

ADDITIONAL REQUIREMENTS:

Possession of a valid New Mexico Driver's License, or the ability to obtain by date of hire. Possession of a City Operator's Permit (COP) within six (6) months from date of hire. Work flexible hours, including evenings and weekends as required.

Must possess one of the following licenses: Licensed Independent Social Worker (LISW), Licensed Clinical Social Work (LCSW), Licensed Professional Clinical Counselor (LPCC), Licensed Marriage and Family Therapist (LMFT), Certified Nurse Practitioner (CNP) or Clinical Nurse Specialist (CNS).
