

PUBLIC NOTICE
Air Quality Construction Permit For
DUKE CITY REDI-MIX, LLC.

Duke City Redi-Mix, LLC. has submitted an application for a modification of an air quality construction permit to the Air Quality Program (Program) of the City of Albuquerque Environmental Health Department. The application was received by the Program on January 6, 2020. The owner of the facility is Duke City Redi-Mix, LLC., 717C West Abrahames Road, Moriarty, NM 87035. The facility, Duke City Redi-Mix, LLC, is located at 7711 Broadway Boulevard, Albuquerque, NM 87105. This application file has been assigned **Permit Application No. 1638-M3**. The Program has made an affirmative administrative completeness determination and is providing this notice pursuant to 20.11.41.14 NMAC.

The applicant is requesting a modification to Permit #1638-M2. The permit modification application proposes to replace the current portable concrete batch plant with a new concrete batch plant with a manufacture rate of 255 cubic yards per hour (cy/hour). The facility is requesting to have a maximum production daily rate of 3150 cy/day and a maximum annual production rate of 1,000,000 cy/year. The hours of operation for the proposed modified facility are 24 hours per day and seven days per week. The new concrete batch plant is a Model Lo-Pro 12-horsepower (hp) portable plant manufactured by CON-ECO and includes the following:

- aggregate/sand storage piles;
- an aggregate/sand feeder and radial conveyor;
- a four-bin aggregate bin;
- a weight batcher with delivery conveyor;
- a cement silo;
- a cement/fly-ash split silo;
- a 12-yard truck loading;
- a cement/fly-ash batcher;
- a central baghouse;
- a fly-ash guppy;
- an existing 3.8 MMBTU/hr hot water heater;
- and concrete additive.

The proposed air pollution maximum allowable emissions from this facility have been estimated to be:

¹The proposed total emissions in this notice could change slightly during the course of the Program's review of the application.

The Program has conducted a preliminary review of the air quality modeling information submitted with the permit application. The Program's preliminary review and the applicant's analysis of ambient air quality impacts indicate that the facility's air emissions will meet the air quality standards for CO, NO_x, SO₂, and Particulate Matter (both PM₁₀ and PM_{2.5}). In regards to the ozone air quality standard, ozone is normally only modeled for regional compliance demonstrations and does not need to be modeled for air quality permits subject to certain exceptions not applicable here. A copy of the permit application, all supporting documentation, and the Program's technical analysis, if and when it is completed, may be inspected by the public at the Program offices at Room 3047, One Civic Plaza NW, Albuquerque, NM. Any person who wishes to receive notice of the availability of the Program's technical analysis for review and comment, must express request notice in writing to the Program at: Albuquerque Environmental Health Department, Air Quality Program – Permitting Section P.O. Box 1293, Albuquerque, New Mexico 87103 before the **end of the public comment period on April 2, 2020**. The public will have no fewer than 30 days to submit written comments and evidence, request a public information hearing, or both on the permit application to the Program. Comments will be accepted and considered if postmarked by the end of the public comment period. Formal action on the application will be reserved pending receipt and analysis of any additional details or information developed during the public comment period. Any person who does not participate in the permitting action will not receive notification of the Program's decision regarding the proposed permit, unless the person has delivered a written request for notice to the department. The application, all supporting documentation, and the public notice are available online at <http://www.cabq.gov/airquality/air-quality-permits>.

The Program shall hold a Public Information Hearing pursuant to 20.11.41.15 NMAC if the Director determines there is significant public interest and a significant air quality issue is involved.

The Program expects to issue, issue subject to conditions, or deny this application before May 22, 2020. The Program will not issue any air quality permit with or without conditions unless an air quality ambient impact dispersion modeling study, if deemed necessary by the Program, shows that the facility would not cause or contribute to a potential violation of air quality standards. If the Program issues the permit with conditions, the conditions will include those that limit the emissions, and conditions that will require recordkeeping and reporting to the Program to ensure compliance with federal and local air regulations.
