

**NOTICE OF RESCHEDULING OF THIRD PUBLIC INFORMATION HEARING
FOR AIR QUALITY CONSTRUCTION PERMIT APPLICATION #3340
FOR NEW MEXICO TERMINAL SERVICES, LLC**

The **June 27, 2019** Third Public Information Hearing (third hearing) for the New Mexico Terminal Services Air Quality Construction Permit Application #3340 **has been re-scheduled**. **The third hearing has been rescheduled for July 24, 2019** from 6:00 p.m. to 8:00 p.m. at the Mountain View Community Center, 201 Prosperity Ave SE, Albuquerque, NM 87105. The third hearing is open to the public and will be held to provide information and answer questions regarding the Air Quality Construction Permit Application #3340 for New Mexico Terminal Services, LLC. This notice provides a summary of this proposed activity and explains the reason for the third hearing. The Air Quality Program (Program) of the City of Albuquerque Environmental Health Department has not yet made a final decision on the application.

On February 23, 2018, New Mexico Terminal Services, LLC submitted an application to the Program for a new air quality construction permit. The application requests to construct and operate a hot mix asphalt plant (HMA), a railcar unloading terminal, truck loading operations, and aggregate and recycled asphalt pavement (RAP) products handling facility (Facility). The proposed types of equipment to be operated at the Facility is described in more detail below. The proposed location is 9615 Broadway Blvd. SE in Albuquerque, New Mexico 87105. The applicant's name is New Mexico Terminal Services, LLC, and the applicant's address is 9615 Broadway Blvd. SE, Albuquerque, NM 87105.

The Program has reviewed the air quality dispersion modeling for this Facility. The Program's review indicates that the Facility's air emissions will meet the air quality standards for Nitrogen Oxides (NOx), Carbon Monoxide (CO), Sulfur Oxides (SOx), Particulate Matter <10 microns (PM-10), and Particulate Matter <2.5 microns (PM-2.5). In regards to the ozone air quality standard, ozone is normally only modeled for regional compliance demonstrations and does not need to be modeled for air quality permits subject to certain exceptions not applicable here. Prior to making a final decision on the application, the Program will make any necessary final evaluations of the estimated emission rates for this Facility to assess compliance with ambient air quality requirements and standards. The number of the proposed permit, if issued, will be #3340-RMD.

The Program estimates that the maximum allowable emissions from this proposed Facility would be:

*These columns factor in the Facility's operational limits that the permit would impose, if issued.

The equipment and activities proposed to be operated at the Facility will consist of one (1) rail hopper, one (1) rail hopper conveyor, one (1) rail telescoping conveyor, one (1) aggregate truck loading, one (1) HMA scale conveyor,

one (1) HMA slinger conveyor, one (1) hot mix drum, one (1) hot mix drum baghouse, six (6) cold feed bins, one (1) cold feed conveyor, one (1) cold feed scalping screen, one (1) scalping screen conveyor, one (1) cold feed pug mill, one (1) mineral filler silo, one (1) mineral filler silo baghouse, one (1) HMA RAP bin, two (2) HMA RAP screen conveyors, one (1) HMA RAP screen, one (1) HMA RAP screen conveyor, one (1) HMA incline conveyor, one (1) fuel oil fired hot oil heater, two (2) HMA cement storage tanks, one (1) RAP crusher plant, one (1) RAP crusher plant conveyor, three (3) HMA silos, HMA yard, plant haul roads, and aggregate/RAP storage piles. The maximum and normal operating schedules for this Facility will be:

Maximum Operating Schedule:

The proposed permit would authorize all of the above equipment to operate 24/7 March through November.

Normal Operating Schedule:

- a. March through November, all equipment and activities may operate 24/7.
- b. December through February, all equipment and activities restricted to 17 hours per day, from 4am to 9pm, except that the following equipment may operate 24/7 year round: railcar hopper, rail hopper conveyor, rail telescoping conveyor, aggregate truck-loading, HMA heater, and paved and unpaved aggregate haul roads.

The Program previously held a hearing for this application on August 30, 2018 and issued a permit on September 19, 2018. On October 26, 2018, certain petitioners requested a hearing before the Albuquerque-Bernalillo County Air Quality Control Board (Air Board) regarding the permit. In preparing the Administrative Record, the Program realized that it had not published the public notice for the August 30, 2018 hearing in the newspaper as required. The Program informed the petitioners and the permittee of this issue and requested that the Air Board reverse and remand the permit to the Program for further processing. The Air Board issued an order reversing and remanding the permit to the Program on February 22, 2019.

The Program published the notice for the second public information hearing (second hearing) in the newspaper on March 24, 2019 and the second hearing was held on April 24, 2019. However, the second notice contained an erroneous day of the week for the second hearing (e.g. "Thursday April 24, 2019" when April 24 was a Wednesday). The Program is holding a third hearing to assure that the public is given clear notice of the date and time. This public notice informs the public of the date and time of this third hearing, and informs the public how to obtain additional information or comment, if desired.

AVAILABILITY OF INFORMATION: A copy of the complete application file to date and the Air Board's February 22, 2019 Order, among other things, are available for inspection at the Program offices at the physical address of One Civic Plaza, 3rd Floor, Room 3047, Albuquerque, NM 87102. At the hearing, the Program staff will be available to answer questions regarding the review process for air quality permit applications in general, and the New Mexico Terminal Services, LLC application specifically. The Program has requested that the applicant or its representative(s) attend to answer questions. The public will have a reasonable opportunity to voice concerns and submit data or arguments regarding the application, whether orally or in writing. Those who wish to speak at the July 24, 2019 hearing should sign the registry upon arriving at the hearing. A hearing

officer will direct the proceedings and is authorized to limit the length of testimony, if necessary, so that all members of the public who wish to speak will have an opportunity to do so.

After the hearing, the Program staff will evaluate the entire application file before making a decision on the application. This includes, but is not limited to, public comments received and relevant testimony and documentation submitted at the hearings that were held on August 30, 2018 and April 24, 2019, and the third hearing to be held on July 24, 2019. All persons who have previously commented on this application and who have also provided contact information to the Program, will be provided notice of the Program's decision.
