NOTICE OF PUBLIC INFORMATION HEARING FOR PROPOSED AIR QUALITY CONSTRUCTION PERMIT APPLICATION #359-M3 FOR CORESLAB STRUCTURES (ALBUQUERQUE) INC

A Public Information Hearing (hearing) will be held on Thursday, January 10, 2019 from 6:00 p.m. to 8:00 p.m. at the Herman Sanchez Community Center, 1830 Williams SE, Albuquerque, NM 87102. The purpose of the hearing is to provide information and answer questions regarding the proposed Air Quality Construction Permit Application #359-M3 for Coreslab Structures (Albuquerque) Inc. The location was chosen to accommodate the significant public interest that has been expressed in this matter.

Coreslab Structures (Albuquerque) Inc. has submitted an air quality construction permit application to the Air Quality Program (Program) of the City of Albuquerque Environmental Health Department for modification to Construction Permit #359-M2-RV1 for their concrete batch plant. The owner of this facility is Coreslab Structures (Albuquerque) Inc., 2800 2nd St. SW, Albuquerque, NM 87102.

The 240 yd³/hr concrete batch plant facility is located at 2800 2^{nd} St. SW in Albuquerque, New Mexico. The modification proposes to add a 300 gallon above-ground gasoline tank and two 12 ft³/hr sandblasters. The facility includes a concrete plant, which includes storage bins, conveyors, sand and gravel hopper, cement hopper, (2) mixers, (3) 100-ton capacity storage silos, and (6) natural gas fired boilers.

The maximum air pollution emissions to the atmosphere from this facility have been estimated to be;

Carbon Monoxide (CO) - 1.0 pounds per hour (lbs/hr) - 2.3 tons per year (tpy), Nitrogen Oxides (NOx) - 1.3 lbs/hr - 2.7 tpy, Sulfur Oxides (SOx) - 0.01 lbs/hr - 0.01 tpy, Total Suspended Particulates (TSP) - 1.7 lb/hr - 2.2 tpy, 10 Micron Particulate Matter (PM₁₀) - 0.6 lb/hr - 0.8 tpy, Volatile Organic Compounds (VOC) - 0.1 lb/hr - 0.2 tpy

Representatives for Coreslab Structures (Albuquerque) Inc. will speak regarding the proposed Construction Permit Application. Program staff will be available to answer questions regarding the review process for air quality permits and the status of Coreslab Structures (Albuquerque) Inc. Construction Permit Application #359-M3. The public will have an opportunity to voice concerns and submit data or arguments, orally or in writing, for the public record regarding the application. Those who wish to do so at the January 10, 2019 hearing should sign the registry upon their arrival at the hearing. A hearing officer will direct the proceedings and is authorized to limit the length of the testimony.

Program staff will consider relevant testimony and documentation submitted at the hearing before making a decision on the Construction Permit Application.
