Albuquerque Geographic Information System – AGIS

The AGIS Division is the primary geographic information system group in the City of Albuquerque. AGIS maintains and updates dozens of layers of information in a computerized mapping format. This information allows for geographic analysis used by City officials to gain a better understanding of existing conditions in Albuquerque. AGIS also makes specialized maps for the Planning Department and other City departments, the City Council and various government agencies. For the general public, AGIS publishes the *City Zone Atlas* and keeps a list of standard maps available at a reasonable cost.
