- 6. The Vacation must be must be platted within one year of City Council approval or it will be void (see Table 6-4-3 of the IDO)
- 7. A note must be added to the Plat confirming access to the entrance to the Hahn Arroyo by AMAFCA, and that the access will not be blocked.
