On September, 11 2024, the Development Hearing Officer (DHO) held a public meeting concerning the above referenced application and **denied** the request, based on the following Findings:

- 1. This is a waiver request to keep the existing sidewalks along Seven Bar Loop at their existing width of 5-feet to 6.4-feet. The DPM Table 7.2.29 requires 10-foot-wide sidewalks along Seven Bar Loop at this location because it is an Activity Center.
- 2. Transportation Engineers reviewed the waiver request and did not find the Applicant made sufficient justification to waive the required wider sidewalk. The existing sidewalk could remain with an additional widening of 3-5 feet.
- 3. The DHO made no findings or conclusion regarding IDO 6-6(P)(3)(b)(2) because the threshold question of no significant public purpose was not satisfied and, therefore, findings for these criteria were not necessary.
