Summary of Analysis


The applicant has requested a 30-day deferral to the July 18th, EPC Hearing to ensure compliance with all site plan requirements.

The request is for a Site Plan EPC Major Amendment to the controlling approximately 3.5-acre Wyoming Commercial Complex Site Development Plan for Subdivision for an approximately 1.0-acre site legally described as all or a portion of Tract C-1-A, Plat of Tracts C-1-A thru C-1-E Academy Acres Unit 17, located at 7330 San Antonio Dr. NE, between San Antonio Dr. NE and San Antonio Place NE (the "subject site"). The requested major amendment is to add a restaurant with drive-thru use on the subject site, which is being reviewed as a new Site Plan as part of this request.

The site is currently zoned MX-L (Mixed-use low intensity). For the purposes of this request, staff has reviewed the proposed Site Plan pursuant to development standards listed on the controlling SDP and the MX-L zone district.

Staff agrees with the request for deferral.

I spoke with Sabrina earlier this afternoon and understand that you are out of the office until 6/5/24.
