

Summary of Analysis

The request is for a Site Plan-EPC for an Extraordinary Facility for the San Antonio Oxbow Open Space, containing approximately 100-acres. The request is being heard because any Extraordinary Facility must be reviewed and decided pursuant to Subsection 14-16-6-6(J) Site Plan – EPC. Compliance with IDO Section 5-2 Site Design and Sensitive Land, is required. The subject site is in an Area of Consistency.

The affected neighborhood organizations (NAs) are the Alvarado Gardens Neighborhood Association, North Valley Coalition, and the Rio Grande Boulevard Neighborhoodd Association which were notified as required. Property owners within 100 feet of the subject site were also notified. A pre-submittal neighborhood meeting was held on May 4, 2022. As of this writing, staff has not been contacted and there is no known opposition.

The applicant requests a 60-day deferral to complete additional site research, clean up the proposed site plan and re-notify the NAs about changes (see attached deferral request letter). Staff agrees with the request for deferral.
