**Summary of Analysis**

The request is for a site development plan for subdivision (SPS) with design standards for an  $\approx 7.2$  acre site. The proposed SPS would consolidate two lots and create four new ones.

The applicant envisions various commercial uses, such as restaurants, banks and retail, and an office use in the future. Delegation of review authority to the DRB is requested.

The subject site is in the Established Urban area of the Comprehensive Plan and is in the Journal Center Major Activity Center. The North Valley Area Plan also applies. A TIS was required and has been completed.

Neighbors and property owners were notified as required.

The applicant is requesting a 30 day deferral to the August 13, 2015 hearing to allow additional time to work on the proposed design standards.

**Findings:**

1. This request is for a site development plan for subdivision with design standards.
2. The applicant requests a 30-day deferral to the August 13, 2015 EPC hearing in order to allow additional time to work on the design standards.
