Summary of Analysis

This two-part request is for a new Site Plan-EPC and a Variance-EPC to facilitate development of a Travel Stop on approximately 7 acres of the northern portion of the Tract.

The EPC is hearing this request because the subject site is within the Railroad and Spur Small Area and meets the criteria for a Cumulative Impacts Analysis pursuant to IDO 14-16-6-2(E). The subject site is in an Area of Change and not in an Activity Center or along a Corridor.

The affected neighborhood organization is the San Jose Neighborhood Association, which was notified as required. Property owners within 100 feet of the subject site were also notified as required.

The applicant requests a one-month deferral to the June 15, 2023 hearing. The applicant requested more time to incorporate revisions to the request.
