

## CITY OF ALBUQUERQUE OFFICE OF ADMINISTRATIVE HEARINGS ZONING HEARING EXAMINER NOTIFICATION OF DECISION

RONALD CORIO requests a special exception S to Section 14-16-2-19(B) and 14-16-2- P 20(B)(1)(c): a CONDITIONAL USE to allow an existing outside storage of building material or sales in an IP zone for all or a portion of Lot BIBIA1, ABQ INDUSTRIAL PARK SITE zoned IP, located on 3901 MIDWAY PL NE (E-17)

On the 21st day of July, 2015 (hereinafter "Hearing") RONALD CORIO (hereinafter "Applicant") appeared before the Zoning Hearing Examiner (hereinafter "ZHE") requesting a Conditional Use to allow an existing outside storage of building material or sales in an IP zone (hereinafter "Application") upon the real property located at 3901 MIDWAY PL NE ("Subject Property"). Below are the findings of facts:

## **FINDINGS:**

- 1. Applicant is requesting a Conditional Use -to allow an existing outside storage of building material or sales in an IP zone.
- 2. The City of Albuquerque Code of Ordinances Section § 14-16-4-2 (C) (1) (a) "SPECIAL EXCEPTIONS" reads in part: "A conditional use shall be approved if and only if, in the circumstances of the particular case and under conditions imposed, the use proposed will not be injurious to the adjacent property, the neighborhood, or the community."
- 3. Applicant testified at the Hearing that the Conditional Use, if approved, will not be injurious to the adjacent property, neighborhood, or the community because the Subject Property has already been used in that manner for several years without complaint, the storage yard is hidden from the street and not visible from other properties and backs up to a drainage easement. The proposal does not reduce existing super adequate landscaping and will allow for reasonable commercial use and expansion of the business on the Subject Property. No negative comments were received and the Applicant knows of no objections in an area that the ZHE finds is appropriate for the proposed storage use.
- 4. The City of Albuquerque Code of Ordinances Section § 14-16-4-2 (C) (1) (b) "SPECIAL EXCEPTIONS" reads in part: "A conditional use shall be approved if and only if, in the circumstances of the particular case and under conditions imposed, the use proposed will not be significantly damaged by surrounding structures or activities."
- 5. Applicant testified at the Hearing that the proposed conditional use, will not be significantly damaged by the surrounding commercial structures or commercial

- activities which are compatible with the proposed use. This is demonstrated by Applicant's existing use in inadvertent violation of applicable ordinances, and there is no indication that the proposed use could be subject to damage.
- 6. The yellow "Notice of Hearing" signs were posted for the required time period as articulated within City of Albuquerque Code of Ordinances § 14-16-4-2 SPECIAL EXCEPTIONS.
- 7. The Applicant has adequately justified the Conditional Use request pursuant to City of Albuquerque Code of Ordinances § 14-16-4-2 SPECIAL EXCEPTIONS.

## **DECISION:**

**APPROVAL** of a CONDITIONAL USE to allow an existing outside storage of building material or sales in an IP zone.

If you wish to appeal this decision, you may do so in the manner described below:

Appeal is to the Board of Appeals within 15 days of the decision. A filing fee of \$105.00 shall accompany each appeal application, as well as a written explanation outlining the reason for appeal and a copy of the ZHE decision. Appeals are taken at 600 2nd Street, Plaza Del Sol Building, Ground Level, Planning Application Counter located on the west side of the lobby. **Please present this letter of notification when filing an appeal.** When an application is withdrawn, the fee shall not be refunded.

An appeal shall be heard by the Board of Appeals within 45 days of the appeal period and concluded within 75 days of the appeal period. The Planning Division shall give written notice of an appeal, together with a notice of the date, time and place of the hearing to the applicant, a representative of the opponents, if any are known, and the appellant.

Please note that pursuant to Section 14. 16. 4. 4. (B), of the City of Albuquerque Comprehensive Zoning Code, you must demonstrate that you have legal standing to file an appeal as defined.

You will receive notice if any other person files an appeal. If there is no appeal, you can receive building permits any time after the appeal deadline quoted above, provided all conditions imposed at the time of approval have been met. However, the Zoning Hearing Examiner may allow issuance of building permits if the public hearing produces no objection of any kind to the approval of an application. To receive this approval, the applicant agrees in writing to return the building permit or occupation tax number.

Successful applicants are reminded that other regulations of the City must be complied with, even after approval of a special exception is secured. This decision does not constitute approval of plans for a building permit. If your application is approved, bring this decision with you when you apply for any related building permit or occupation tax number. Approval of a conditional use or a variance application is void after one year from date of approval if the rights and privileges are granted, thereby have not been executed or utilized.
