

# CITY OF ALBUQUERQUE OFFICE OF ADMINISTRATIVE HEARINGS ZONING HEARING EXAMINER NOTIFICATION OF DECISION

Jerome Deroy & Kia Margarida Ramirez (Agent, Renaissance Man Construction, LLC) requests a taller wall permit major for Lot A, Block 13, Loma Vista Addn, located at 1012 Dartmouth DR NE, zoned R-1B [Section 14-16-5-7(D)(3)(g)]

On the 19th day of July, 2022, Renaissance Man Construction, LLC, agent for property owners Jerome Deroy & Kia Margarida Ramirez ("Applicant") appeared before the Zoning Hearing Examiner ("ZHE") requesting a taller wall permit major ("Application") upon the real property located at 1012 Dartmouth DR NE ("Subject Property"). Below are the ZHE's finding of fact and decision:

#### FINDINGS:

- 1. Applicant is requesting a taller wall permit major.
- 2. The City of Albuquerque Integrated Development Ordinance Section 14-16-6 6(H)(3) Permit-Wall or Fence-Major reads: "An application for a Permit Wall or Fence Major for a wall in the front or street side yard of a lot with low-density residential development in or abutting any Residential zone district that meets the requirements in Subsection 14-16-5-7(D)(3)(g) (Exceptions to Maximum Wall Height) and Table 5-7-2 shall be approved if the following criteria are met:

6-6(H)(3)(a) The wall is proposed on a lot that meets any of the following criteria:

- 1. The lot is at least  $\frac{1}{2}$  acre.
- 2. The lot fronts a street designated as a collector, arterial, or interstate highway.
- 3. For a front yard wall taller than allowed in Table 5-7-1, at least 20 percent of the properties with low-density residential development with a front yard abutting the same street as the subject property and within 330 feet of the subject property along the length of the street the lot faces have a front yard wall or fence over 3 feet. This distance shall be measured along the street from each corner of the subject property's lot line, and the analysis shall include properties on both sides of the street.
- 4. For a street side yard wall taller than allowed in Table 5-7-1, at least 20 percent of the properties with low-density residential development with a side yard abutting the same street as the

subject property and within 330 feet of the subject property along the length of the street the lot faces have a street side yard wall or fence over 3 feet. This distance shall be measured along the street from each corner of the subject property's lot line, and the analysis shall include properties on both sides of the street.

- 6-6(H)(3)(b) The proposed wall would strengthen or reinforce the architectural character of the surrounding area.
- 6-6(H)(3)(c) The proposed wall would not be injurious to adjacent properties, the surrounding neighborhood, or the larger community.
- 6-6(H)(3)(d) The design of the wall complies with any applicable standards in Section 14-16-5-7 (Walls and Fences), including but not limited to Subsection 14-16-5-7(E)(2) (Articulation and Alignment), Subsection 14-16-5-7(E)(3) (Wall Design), and all of the following:
  - 1. The wall or fence shall not block the view of any portion of any window on the front façade of the primary building when viewed from 5 feet above ground level at the centerline of the street in front of the house.
  - 2. The design and materials proposed for the wall or fence shall reflect the architectural character of the surrounding area.
- 3. The applicant bears the burden of providing a sound justification for the requested decision, based on substantial evidence, pursuant to IDO Section 14-16-6-4(E)(3).
- 4. The applicant bears the burden of showing compliance with required standards through analysis, illustrations, or other exhibits as necessary, pursuant to IDO Section 14-16-6-4(E)(4).
- 5. Kia Margarida Ramirez and Richard Burd, Renaissance Man Construction, LLC, agent for property owner Jerome Deroy, appeared and gave evidence in support of the application.
- 6. The subject property is currently zoned R-1B.
- 7. Based on photographs, maps and oral evidence presented by Agents, at least 20 percent of the properties within 330 feet of the lot where the wall or fence is being requested have a wall or fence over 3 feet in the applicable area.
- 8. Based on evidence presented by Applicant, the proposed wall would strengthen or reinforce the architectural character of the surrounding area. Specifically, Agents confirmed in oral testimony and in evidence submitted that the proposed wall would not be out of character with the surrounding area, but rather would reinforce the architectural character of the neighborhood by being in harmony with the other improvements on the Subject Property. Specifically, photographs were submitted showing several walls/fences in the neighborhood, and according to Agents' testimony the proposed wall's materials and color would match the existing house structure.
- 9. Based on evidence presented by Applicant, the proposed wall would not be injurious to adjacent properties, the surrounding neighborhood, or the larger community. Specifically, Agents confirmed in oral testimony and evidence submitted that the wall would enhance the safety of both the subject property and neighboring properties.
- 10. Based on evidence presented by Applicant, the design of the wall complies with any applicable standard in Section 14-16-5-7 (Walls and Fences), including, but not limited to Subsection 14-16-5-7(E)(2) (Articulation and alignment) and Subsection 14-16-5-7(E)(3) (Wall Design), and all of the following: (a) The wall or fence shall not block the view of

any portion of any window on the front façade of the primary building when viewed from 5 feet above ground level at the centerline of the street in front of the house; and (b) The design and materials proposed for the wall or fence shall reflect the architectural character of the surrounding area.

- 11. The City Traffic Engineer submitted a report stating no objection to the Application.
- 12. All property owners within 100 feet and affected neighborhood association(s) were notified.
- 13. The ZHE finds that the proper "Notice of Hearing" signage was posted for the required time period as required by Section 14-16-6-4(K)(3).
- 14. The ZHE finds that the Applicant has authority to pursue this Application.

### DECISION:

APPROVAL of a taller wall permit major.

## APPEAL:

If you wish to appeal this decision, you must do so by August 18, 2022 pursuant to Section 14-16-6-4(V), of the Integrated Development Ordinance, you must demonstrate that you have legal standing to file an appeal as defined.

If your application is approved, bring this decision with you when you apply for any related building permit or occupation tax number. Jerome Deroy & Kia Margarida Ramirez (Agent, Renaissance Man Construction, LLC) requests a variance of 3 ft to the required 3 ft wall in the front and street side yard for Lot A, Block 13, Loma Vista Addn, located at 1012 Dartmouth DR NE, zoned R-1B [Section 14-16-5-7(D)]

On the 19th day of July, 2022, Renaissance Man Construction, LLC, agent for property owners Jerome Deroy & Kia Margarida Ramirez ("Applicant") appeared before the Zoning Hearing Examiner ("ZHE") requesting a variance of 3 ft to the required 3 ft wall in the front and street side yard ("Application") upon the real property located at 1012 Dartmouth DR NE ("Subject Property"). Below are the ZHE's finding of fact and decision:

## **FINDINGS**:

- 1. Applicant is requesting a variance of 3 ft to the required 3 ft wall in the front and street side yard.
- 2. The City of Albuquerque Integrated Development Ordinance, Section 14-16-6-6(O)(3)(a) (Variance-Review and Decision Criteria) reads: "... an application for a Variance-ZHE shall be approved if it meets all of the following criteria:
  - (1) There are special circumstances applicable to the subject property that are not self-imposed and that do not apply generally to other property in the same zone and vicinity such as size, shape, topography, location, surroundings, or physical characteristics created by natural forces or government action for which no compensation was paid. Such special circumstances of the property either create an extraordinary hardship in the form of a substantial and unjustified limitation on the reasonable use or return on the property, or practical difficulties result from strict compliance with the minimum standards.
  - (2) The Variance will not be materially contrary to the public safety, health, or welfare.
  - (3) The Variance does not cause significant material adverse impacts on surrounding properties or infrastructure improvements in the vicinity.
  - (4) The Variance will not materially undermine the intent and purpose of the IDO or the applicable zone district.
  - (5)The Variance approved is the minimum necessary to avoid extraordinary hardship or practical difficulties."

- 3. The applicant bears the burden of providing a sound justification for the requested decision, based on substantial evidence, pursuant to IDO Section 14-16-6-4(E)(3).
- 4. The applicant bears the burden of showing compliance with required standards through analysis, illustrations, or other exhibits as necessary, pursuant to IDO Section 14-16-6-4(E)(4).
- 5. Applicant and agent appeared and gave evidence in support of the application.
- 6. The subject property is currently zoned R-1B.
- 7. Based on evidence submitted by or on behalf of Applicant and oral testimony by Agents, it appears that there are special circumstances applicable to the Subject Property that are not self-imposed and that do not apply generally to other property in the same zone and vicinity such as size, shape, topography, location, surroundings, or physical characteristics created by natural forces or government action for which no compensation was paid, as required by Section 14-16-6-6(N)(3)(a)(1). Specifically, Agent testified and provided written evidence that, the Subject Property has special circumstances because of its location on a corner and the position and orientation of preexisting improvements on the lot, and the topography of the Lot with the Subject Property being on a slope, which places the proposed wall to be uneven. These special circumstances create an extraordinary hardship in the form of a substantial and unjustified limitation on the reasonable use or return on the Subject Property, because compliance with the minimum standards would not allow for the reasonably proposed use that otherwise would be in compliance with the IDO.
- 8. Based on evidence submitted by or on behalf of Applicant, the variance will not be contrary to the public safety, health and welfare of the community as required by Section 14-16-6-6(N)(3)(a)(2). Specifically, evidence was submitted supporting that, if granted approval, the Applicant intends to construct the proposed project in a manner that is consistent with the IDO and the Development Process Manual (DPM).
- 9. Based on evidence submitted by or on behalf of Applicant, the variance will not cause significant adverse material impacts on surrounding properties or infrastructure improvements in the vicinity as required by Section 14-16-6-6(N)(3)(a)(3). Specifically, Agent confirmed in oral testimony and submitted evidence that the proposal is designed to be in harmony and consistency with what currently exists in the neighborhood. The proposal would not be out of character with the surrounding area, but rather would reinforce the architectural character of the neighborhood by being in harmony with the other improvements existing and proposed for the Subject Property.
- 10. Based on evidence submitted by or on behalf of Applicant, the variance will not materially undermine the intent and purpose of the IDO or applicable zone district as required by Section 14-16-6-6(N)(3)(a)(4). Specifically, Agents presented evidence that the intent of IDO will still be met in that the subject site will be in harmony with existing uses and the proposed variance would merely add to the safety and useability of the site.
- 11. Based on evidence submitted by or on behalf of Applicant, the variance approved is the minimum necessary to avoid extraordinary hardship or practical difficulties as required by Section 14-16-6-6(N)(3)(a)(5). Specifically, Agent confirmed in oral testimony and submitted evidence that any smaller variance would be ineffective to provide for the useability of the site. Thus, the applicant is not requesting more than what is minimally necessary for a variance.
- 12. The City Traffic Engineer submitted a report stating no objection to the Application.

- 13. All property owners within 100 feet and affected neighborhood association(s) were notified.
- 14. The ZHE finds that the proper "Notice of Hearing" signage was posted for the required time period as required by Section 14-16-6-4(K)(3).
- 15. The ZHE finds that the Applicant has authority to pursue this Application.

#### DECISION:

APPROVAL of a variance of 3 ft to the required 3 ft wall in the front and street side yard.

### APPEAL:
